- Conducting facility risk control surveys;
- Developing risk control management programs for prevention and improving premises or operations;
- Developing client loss estimates (MFL/PML) on site specific and portfolio basis to assist with insurance program designs;
- Carrying out new facility risk control project reviews and providing related advice;
- Conducting hazard identification and risk assessments at client sites;
- Conducting incident investigations of client losses;
- Developing and delivering hazard awareness and loss prevention training;
- Preparing insurance underwriting information reports and plot plans;
- Evaluating and responding to insurance company recommendations;
- Managing performance development, cross-training and succession planning initiatives in support of the attraction, retention and motivation of key talent;
