

Resignation or Transfer to Non-Practising Status

PLEASE READ THIS NOTICE CAREFULLY, AS THE FORM HAS BEEN CHANGED.

USING THIS FORM

Please complete and return this form if you wish to:

- 01) Transfer to **Retired Member** category; or
- 02) Transfer to **On Leave** category; or
- 03) Transfer to the **Life Member** category; or
- 04) **Resign.**

Depending on when change of status occurs, it may result in partial reimbursement of fees paid.

RETIRED MEMBER BY-LAW 7.1.2

Professional members who are not practising and are not intending on returning to practice may enter the Retired Member category:

- A) shall not be practising professional engineering or professional geoscience in Manitoba;
- B) are required to return all seals issued in accordance with Part 8 of the Act.

If a member in the Retired category wishes to revert to Practising, they will be required to make application to the Continuing Competency Committee. Please refer to apegm.mb.ca

ON LEAVE BY-LAW 7.1.3

Professional members who will be away from practice for several years and are intending to return to practice may enter the On Leave category. Examples of situations appropriate for this category are:

- extended parental leave, and
- long-term disability.

Professional members in the Member On Leave category shall not be practising professional engineering or professional geoscience in Manitoba and are required to return all seals.

If a member in the On Leave category wishes to revert to Practising, they will be required to make application to the Continuing Competency Committee. Therefore, it is strongly recommended that members in the On Leave category maintain a record of their professional development activities. Please refer to apegm.mb.ca

LIFE MEMBERSHIP BY-LAW 7.1.4

Life membership may be granted to any practising member or retired member who:

- A) shall not be practising engineering or geoscience; and
- B) is at least 65 years of age; and
- C) has been a member of the Association, or one of the constituent associations of the CCPE for 30 years, or in the case of professional geoscientists has practised or been a member of the Association for a combined total of 30 years; and
- D) has retired from all gainful employment.

Once the Life Membership is granted a member, he or she shall, without further payment of dues, hold the same responsibilities and rights and privileges of members in the retired category.

RESIGNATION BY-LAW 10.1

Members shall return the rubber portion of the seal and the certificate as required per Act 26 (2) and 28 (5).
