PLATFORM PART 2 - THE PUBLIC OF MANITOBA

The Association governs and regulates the professions in the public interest. What is, or what should, Council be doing to ensure that its governance is in the public interest and why?

It is of paramount importance for Council to be knowledgeable of change in the landscape of engineering and geoscience and to carefully consider how or if these are reflected in the Act, By-laws, and Code of Ethics. It is important for Council to utilize their collective experience and knowledge of past and current changes to adjust accordingly, where necessary, to best serve and protect the public interest.

PLATFORM PART 3 - THE ASSOCIATION

Council sets the expectation for the Association by defining the Ends. What is the most important End and why?

While all the Association's Ends all have importance, E-1, E-2, and E-3 are vital as they have direct connotation to the Mission statement of the Association; to serve and protect the public interest by governing and advancing the practices of professional engineering and professional geoscience in accordance with the Act. E-1 and E-3 are important as they ensure the public of qualified practitioners, but E-2 ensures the public that engineers and geoscientists demonstrate a high level of knowledge and experience, which is paramount to the public interest and safety, and hence, my choice for the most important End.

As well, a councillor needs to understand the differences between governance, management, and operations of Engineers Geoscientists Manitoba. A councillor needs to be committed to ensuring that Engineers Geoscientists Manitoba remains responsive and resilient in achieving its goals.
