exposed to a great variety of regulatory frameworks, industry practices, and professional perspectives. I would be honoured to have an opportunity to apply my knowledge and experience to influence governance of our profession. My particular interest is in analyzing how Engineers Geoscientists Manitoba policies and practices align with those of other professional associations and in optimizing our system of accreditation of foreign-trained professionals.

PLATFORM PART 2 - THE PUBLIC OF MANITOBA

The Association governs and regulates the professions in the public interest. What is, or what should, Council be doing to ensure that its governance is in the public interest and why?

As in majority of industries, the field of engineering is experiencing a shortage of talent with not enough young people joining the profession to replace the retiring old guard. One of the ways to address this shortage is to recognize qualified foreign-trained engineers that are coming to our province. However, the need to encourage applicants and streamline the recognition process must be balanced with the need to ensure they are suitably qualified. Finding that balance is challenging, but it is extremely important for addressing the demand while protecting the public and upholding the standing of our profession.

Council sets the expectation for the Association by defining the Ends. What is the most important End and why?

In my view, the most important End is to ensure that practitioners practice with competence and conduct themselves professionally. This End protects the public and upholds the image and respect of the Engineering Profession.

Council sets out the core characteristics of what it considers to be a good councillor in GP-6 Councillor Roles and Job Description. What is the most important characteristic of a good councillor and why?

I think the most important characteristic of a good councillor is the ability to think in terms of systems and context and to see the big picture.
