## **REQUIREMENTS & STEPS**

- You must be a current licensee (Eng.L/Geo.L) with Engineers Geoscientists Manitoba to apply for a scope change.

- Wait for the Registration Committee to determine if the scope change is a minor or major scope change.
  - If the scope change is minor, complete and submit project examples using the templated reporting document.
  - If the scope change is major, complete competency-based assessment in the competency reporting system. You will receive a notification when your account is enabled.
