The MWSB through the Water Services Branch also provides assistance for collection, treatment and disposal of municipal wastewater. The Water Services Branch is looking for a high performing and enthusiastic individual to join our Engineering and Management Team.

#### **Conditions of Employment:**

- Must be legally entitled to work in Canada.
- Valid Manitoba Class 5 driver's license
- Must be registered or be eligible for registration as a Professional Engineer with the Engineers Geoscientists of Manitoba. Candidates eligible for the Engineers Geoscientists of Manitoba EIT program may also be considered.
